

1. School Rules

Meridian Secondary School adopts a Positive Discipline approach to develop good discipline in students. The goal is to instill self-discipline and good character in students and a whole-school, multi-faceted approach is adopted. Discipline is a learning process to develop students' thinking and moral faculties.

A key strategy for developing good discipline is to build students' social and emotional competencies by:

- creating a supportive environment;
- inculcating values and social emotional skills;
- providing opportunities for students to demonstrate good behaviour; and
- guiding students through a reflective journey towards better character development.

School rules are intended to help students cultivate a set of positive behaviours that will empower them to learn and grow in a safe, conducive and meaningful environment. These rules provide clarity in students' behaviour in school, and during Independent Learning Day. Student Management Team (StMT) manages discipline issues of students.

The school is committed to partner parents in ensuring that school rules are observed by all students. Parents are encouraged to contact the school (Tel: 6583 1387) for clarifications.

1. REPORTING TO SCHOOL

1.1 General Information

- Students are to be <u>punctual</u> and <u>seated</u> in their respective classrooms by 7.30 am. Students will be considered late if they fail to do so.
- STUDENTS ARE TO WEAR THE PRESCRIBED SCHOOL UNIFORM AND ANY MODIFICATION TO THE UNIFORM IS NOT ALLOWED.
- MALE STUDENTS MUST BE CLEAN-SHAVEN AND NEAT IN APPEARANCE AT ALL TIMES.
- STUDENTS WHO ARE SINGAPORE CITIZENS MUST SING THE NATIONAL ANTHEM AND TAKE THE PLEDGE. STUDENTS WILL TAKE THE PLEDGE WITH THE RIGHT FIST OVER THE HEART.
- ALL STUDENTS ARE NOT ALLOWED TO HAVE ANY WEAPON IN THEIR POSSESSION. THEY ARE ALSO NOT ALLOWED TO BRING ANY WEAPON-LIKE ITEM WHICH CAN BE USED OR INTENDED TO BE USED TO CAUSE HARM TO OTHERS.

- All students must be in school attire when reporting and leaving the school.
- Students who are not in proper school attire, hairstyle, or hair colour will not be allowed to enter the school premise.
- Parents will be informed if there are special events that require the participation of their children. If clarification is needed, parents are encouraged to contact the school for information.
- The school General Office will be closed on Saturdays, Sundays and Public Holidays. However, some school activities may be arranged on weekends and parents will be notified.
- Photograph(s) or video image(s) of students and their parents may be captured during school activities and events such as classroom lessons, CCA, school camps, and school concerts. The school may use and publish such photographs and/or video recordings in school publications, website, social media channels, and other communication channels.

1.2 Attendance

- Students or their parents must inform the Form Teacher/s school if they are unable to attend school as soon as possible on the day of their absence. If the school is not informed by 9.30 am on that/ or any day, you will be marked as absent and your parents will be informed by SMS.
- Absence from school must be supported by a medical certificate from MOHregistered clinics or parents' letter (maximum 2 per term). Students/ parents can communicate the reasons for their absence via:
 - a) Direct email to their Form Teachers (*email addresses can be found on school's website)
 - b) Calling the school's General Office at 65831387
 - c) Submitting a hard copy of the MC/ letter to the Form Teachers on the day the student returns to school.
- Students who are absent from school without valid reasons will serve detention after school hours.
- For students with persistent absenteeism, their parents will be invited to the school to meet up with the School Leaders, Year Heads and HOD Student Management.
- Students who are absent without valid reasons for more than 5 times per semester will be accorded a FAIR conduct grade and have to meet the Year Heads/School Leaders. Students are required to complete their school work during detention.
- Students who are absent without valid reasons for more than 9 times per semester will be accorded a POOR conduct grade and meet School Leaders. Students are required to complete their school work during detention.

1.3 Punctuality

- Students must observe punctuality at all times for all school-related activities.
- Students who report to the <u>stipulated venues in school</u> after 7.30 am are considered late.
- The follow-up actions for late coming are shown in the table. The latecoming count is reset every term.

 Students who need to serve detention will not be allowed to attend CCA trainings, remedial lessons and other school programmes on that day.

2. CONDUCT IN SCHOOL

2.1 Movement in School during Curriculum Time

- Students are to move as a class in an orderly manner when moving from one venue to another during curriculum time.
- Students are **NOT** permitted to leave their classrooms during lesson time without a permission pass.
- During lesson time (including change of periods), students are only allowed to visit the toilet with a **permission pass** which can be obtained from their teachers.
- One pass will allow a maximum of two students to leave the class. To minimize
 loss in learning, students are strongly encouraged to visit the toilet before flagraising ceremony, during recess and after school hours.
- Staff toilets are OUT OF BOUNDS to all students.
- Students can only enter special rooms e.g. Computer Labs, Science Labs, NFS Kitchen & Food Lab, D&T Workshops under the supervision of a teacher.

2.2 Conduct in Classroom during Curriculum Time

- Students are to stand up and greet their teachers before the commencement and at the end of lessons.
- Students should participate actively during lessons and always have their learning materials ready.
- Students are to behave in a respectful manner in class. Students who display disruptive behaviour may be referred to the StMT for disciplinary consequences.
- Students are to keep their classrooms clean and tidy at all times.
- Students are advised to not leave their personal belongings including their personal learning devices unattended **AT ALL TIMES**.
- All classrooms must be locked when no one is using the classroom (e.g. recess, movement to special rooms and PE).
- Student who brings a ball to school should carry it in a ball-bag or plastic bag. Balls that are not in a bag may be safe-kept and returned after school.

- Students must **NOT** leave any books behind in the classrooms after school dismissal, unless permitted by a teacher. They may use the allocated personal lockers allocated. These are found outside their classroom.
- To maintain a respectful learning environment, personal learning devices (e.g. Chromebook) may not be used during lessons unless instructed for use by teachers.
- Students who are not on task when using personal learning devices during lessons may be referred to StMT for discipline consequences.

2.3 Conduct in Canteen

- Students must be considerate and observe good dining etiquette at all times. They should refrain from speaking loudly or running in the canteen.
- Students must queue up when buying food.
- Students are to return their crockery and utensils after their meals and keep the canteen clean by not littering.
- Food and drinks (except mineral water) are **NOT** to be brought out of the canteen.
- Students are NOT allowed to purchase or consume food in the canteen during lesson time.

2.4 School Uniform

- Students are to wear the prescribed school uniform whenever they come to school, including during the term and semester breaks. Modifications to the prescribed school uniform are strictly NOT allowed.
- These are examples of the prescribed school uniform.

b) Polo T-shirt and bottoms.


c) CCA shirt/Class Tshirt and school bottoms.

- Students are allowed to wear approved PE attire for PE lessons and during sports and games. Students may report to school in PE attire from the start of the day if they have PE lessons for the day.
- On days when students have CCA, they are allowed to wear their CCA attire. On Fridays, students are allowed to wear their class T-shirts, if any.
- Boys should NOT taper or modify the pants such that it does not conform to the intended look of the uniform. Pants which are deemed to be unacceptable will need to be changed.

- Culottes' length should be at the knee level. Culottes which are too short will need to be changed.
- Students may wear their jackets/sweaters only when they are in air-conditioned venues (e.g. Hall, Auditorium, AVA and other special rooms) or when the weather is cold.
- Students are encouraged to wear Meridian jackets in school. Alternatively, they
 may wear plain jackets without hoods or sweaters without hoods that are
 black, white or grey in colour.
- Students must wear the school uniform and be properly attired when attending school activities during the term break or school holidays. Students who do not conform will NOT be allowed into the school compound.
- Students are to don event-appropriate attire for school programmes. Students
 may be asked to purchase the Meridian shirt to attend formal events like
 ceremonies.

2.5 Hairstyle and Grooming for Boys

- d) Boys' hairstyle should be short and neat. Fringe when combed down should not touch or cover the eyebrows. Hair at the back of the neck should be sloped and clearly above the collar.
- e) Boys with inappropriate hairstyles will be sent out of school to have their hair cut. Parents will be informed by phone. They will be allowed to return to school after the hairstyle has been corrected.
- f) No dyeing of hair is allowed. Boys with dyed hair will be asked to leave the school immediately to dye their hair black and parents will be informed by phone.
- g) Caps are **NOT** to be worn with the school uniform unless required for safety reasons during school-organised activities.
- h) Hairstyles such as side-shaven, undercut, long fringes, razor lines across etc. are not allowed. It is advisable for a student to check with the Form Teacher/ Year Heads/ Student Management Team the intended hairstyle before getting a new hairstyle.




Fringe is short and above the eyebrow.

Note: Burst-fade, mullet, overlap, undershave, undercut, fade or other outlandish hairstyles are not allowed. Fanciful razor lines on the head are **NOT** allowed.


Side of hair does not touch the ears.

Male students are to be clean-shaven and neat in appearance at all times.



2.6 Hairstyle and Grooming for Girls

- Girls' hair should be neat and well-groomed. Girls with shoulder-length hair or hair touching the collar must tie up their hair at all times. Long fringes must be clipped up so that they do not touch the eyebrows.
- Girls with long hair should have their hair tied up in a ponytail or simple plaits. No multi-numbered plaits or fanciful hairstyles are allowed.
- Hair accessories should be black or dark brown.
- i) Girls with inappropriate hairstyles will be sent out of school to have their hair cut. Parents will be informed by phone. They will be allowed to return to school after the hairstyle has been corrected.
- No dyeing of hair is allowed. Girls with dyed hair will be asked to leave the school immediately to dye their hair black and parents will be informed by phone.
- For safety reasons, caps are **NOT** to be worn inside the school compound.



2.7 Shoes and Socks

 Students should wear only black canvas/sports shoes (only minimal white trimmings are allowed) and plain white socks that are clearly seen above the ankles. Shoes may or may not come with laces. High-cut shoes are NOT allowed.



White socks are visible over the ankle.

- In alignment with the school's value of 'Humility', students must refrain from wearing shoes that are expensive and/or fanciful.
- Students with improper shoes will be given a warning and Form Teachers will inform parents. Should they repeat the offence, they will be sent home to change to an acceptable pair of school shoes.
- Students are **NOT** allowed to wear slippers or sandals to school at any time. For students with foot problems, medical certificate from a doctor or permission must be obtained through Form Teachers, YHs or StMT.

2.8 Others

- Students are NOT allowed to wear make-up, apply mascara or eyeliner.
- Fingernails must be kept short, clean and unvarnished.
- Students are NOT allowed to wear any form of jewelry. Girls are allowed to wear only one pair (one on each ear lobe) of black, gold or silver pin-sized ear studs or transparent ear sticks.
- Students with multiple earrings/studs will have their earrings/studs confiscated and students can retrieve them at the end of the semester. The same will apply for <u>unacceptable</u> earrings/studs/sticks.
- No coloured ear sticks, tongue studs, brooches, waistbands or accessories are to be worn with the school uniform.

- Students are NOT allowed to wear dark or tinted glasses unless certified by a doctor or ophthalmologist.
- Fashionable frames with fanciful colours and coloured contact lenses are NOT allowed.
- Tattoos are strictly not allowed on any part of the body. Students found with tattoos will be **suspended** from school until efforts are made to remove them.

3. OTHER RULES AND REGULATIONS

3.1 Handphones and Electronic Devices

- To provide a conducive learning environment for students, the school strongly discourages students from bringing electronic devices or other expensive items to school. In particular, handphones are a great source of distraction for students in classrooms.
- Students are **not to use smartphone and/or smartwatches during lessons** unless explicit permission is given by the teacher.
- Any smartphone or communication device found with a student during such hours will be confiscated. Handphones may be retained up to a term, at the discretion of the HOD Student Management. The SIM card will be returned to the students.
- All smartphones and/or communication devices should be turned off (not just put on silent mode) and locked away in the lockers designated to each classroom before the start of the first lesson. The CCTV surveillance system in the classroom blocks monitor movement of students and usage of the lockers. Students should bear responsibility for safekeeping these devices.
- At the end of the school day, students will retrieve their handphones and/or communication devices from the lockers. Students must ensure their handphones are kept on silent mode as long as they are in school.
- In the case of an emergency, parents/guardians are advised to call the school General Office at 65831387. For a non-emergency situation, they should leave a message to their child/ward's handphone to return a call after school dismissal.
- In the event of loss of electronic devices or other expensive items (such as Bluetooth earpieces, Air pods, Chromebooks, etc.) due to student negligence, the school will not be held responsible.
- Personal learning devices (e.g Chromebooks) may only be used for learning purposes in the classrooms under the instruction of teachers during curriculum time.

Any student who is found to have repeatedly violated the Electronic Devices
policy will have the device confiscated. The device will be kept with StMT and
returned to the student after the parent/guardian has been informed.

4. SERIOUS OFFENCES

- In line with the school's aim of nurturing leaders of sound character, the school adopts Positive Discipline as a whole-school approach in the area of student management. Students will be asked to reflect on the misconduct made and learn from that experience. The school believes in involving both the student and his/her parent/guardian in working out the appropriate intervention to allow the student to take responsibility for his/her actions.
- The school reserves the right to inspect students' mobile phones/devices and online activities if there is a need to investigate inappropriate behaviour or violations of school rules. In certain instances, mobile phones/devices might be temporarily withheld to facilitate the investigation process.
- The mobile phones/devices confiscated will be managed by members of the Student Management Team or staff members appointed by them.

4.2 Consequences for Offences

- Students who have committed any serious offence will receive a 'Fair' or a 'Poor' conduct grade. An accumulation of multiple minor offences will be considered as a major offence and may be escalated to the higher authorities.
- Repeat offenders may be placed on prolonged suspension from class and may eventually be expelled from school.
- Consequences for committing minor offences include detention and school service.
- Consequences for committing major offences include suspension from class, school, involvement of the police and other relevant authorities.

4.3 Zero Tolerance Stance on Vaping

2. School Routines



MSS GAME routines



OUTSTANDING ACADEMIC ACHIEVEMENT

EDUSAVE SCHOLARSHIP (ES)


Singaporean students who are within the top 10% of their level and course in terms of academic performance, and have demonstrated good conduct.

EDUSAVE MERIT BURSARY (EMB)

Singaporean students who are not recipients of any Edusave Scholarship are eligible for the Edusave Merit Bursary, if they are within the top 25% of their level and course in terms of academic performance, have demonstrated good conduct, and whose monthly household income does not exceed \$6,000 (or per capita income does not exceed \$1,500).

EDUSAVE GOOD PROGRESS AWARD (GPA)

Singaporean students who are not recipients of any Edusave Scholarship or the Edusave Merit Bursary, if they are within the top 10% of their level and course in terms of improvement in academic performance and have demonstrated good conduct.



B. Character and Co-Curriculum Awards

MERIDIAN CARING AWARD

Students who exhibit the values of care and concern towards others and are leaders of self.

LEE ZHENG RONG CARING AWARD

Students who exhibit school values and show care and concern towards others. They are positive role-models to their fellow schoolmate. (Up to 4 recipients per year)

CCA DISTINCTION AND MERIT AWARD

Students who have shown excellent CCA performance throughout their 4 or 5 years in their CCA.

EDUSAVE CHARACTER AWARD (ECHA)

Up to 2% of Singaporean students who have demonstrated exemplary character and outstanding personal qualities through their behaviour and actions.

EDUSAVE AWARD FOR ACHIEVEMENT, GOOD LEADERSHIP AND SERVICES (EAGLES)

Up to 10% of Singaporean students who have demonstrated leadership qualities, service to community and schools, excellence in non-academic activities and good conduct.



6. Examination Rules and Regulations

Students' Responsibility

1. Students are expected to familiarise themselves with all pertinent information regarding the examinations and to adhere to the following examination rules.

At the Start of the Examination

- 2. Students sitting for the first paper in the morning must attend the flag raising ceremony.
- Students should be properly attired in school shirt or school polo t-shirt with the school bottoms during examinations. They should not wear CCA or class T-shirts, or PE shorts.
- 4. Students who do not have any examination paper for the day are not required to report to school.
- 5. Students are to report at the examination venue 15 minutes before the start of the exam paper.
- 6. No extra time will be given to latecomers.
- 7. Students are to leave their books, notes, bags etc at the front/ back of the exam venue.
- 8. Students are not allowed to bring mobile phones/ smartwatches/ communication devices/ computerized aids or devices capable of storage/ displaying information into the examination venue.
- 9. Students are to be seated according to their register number.
- 10. Students are to bring their own stationery, mathematical instruments and silent electronic calculators (where permitted). Borrowing and sharing of stationery are not allowed during the test/ examination.
- 11. Students are allowed to use calculators and printed dictionaries or handheld electronic dictionaries (e-dictionaries) indicated in the list of approved calculators and dictionaries. Borrowing and sharing of calculators and/or dictionaries are not allowed during the test/ examination.
- 12. Students who are wearing outerwear (e.g. jackets, cardigan, windbreaker, sweater) into the examination venue must ensure that there are no unauthorized materials or devices in them. Students may be asked to remove the outerwear for checking before or during the examination.

During the Examination

- 13. Students are not allowed to flip open or turn over the question paper and answer booklet or start reading and writing unless they are told to do so by the examination personnel.
- 14. Students must place their student pass, NRIC or foreign identification documents on their desk throughout the examination.
- 15. Students are to check the following: (i) correct <u>paper</u> is given, (ii) correct number of printed pages and the total number of questions in the paper before starting.
- 16. Students should read the instructions on the examination paper carefully.
- 17. Students are to write their answers legibly in dark blue or black ink. Other coloured pencils/pens may be used for maps and diagrams only. Students should use pencils for shading of the Optical Answer Sheet (OTAS).
- 18. Students are not allowed to make use of correction tape or fluid on the answer script or writing paper as it may affect the legibility of answers.
- 19. Students must not turn around and should only face the front during the examination. Students must not communicate or attempt to communicate with any other students/unauthorized person during the examination when communication is strictly prohibited, such as during script collection.
- 20. Students must not write offensive or obscene materials in their answers.
- 21. Students must not exhibit improper conduct or misbehavior during the examination. For example, disturbing other candidates or disobeying instructions from examination personnel.
- 22. Students must not commit or attempt any acts of dishonesty, or support such acts. For example, writing information/notes on any part of the body, taking the examination on someone else's behalf, using unauthorized devices, or giving answers to or obtaining answers from another student.
- 23. Students are not allowed to eat in the examination venue. Students are allowed to drink water and the water bottle must be placed on the floor next to their seats.
- 24. Students are **not allowed** to visit the toilet during the first 30 minutes and the last 30 minutes of the paper.
- 25. Students must not leave the examination venue unescorted or without permission from the examination personnel.

At the End of the Examination

- 26. Students must stop writing after the invigilator has made the announcement to do so. Students are to remain seated quietly while the answer scripts are being collected and counted.
- 27. At the end of the examination, students are to arrange their answers in numerical sequence according to the questions, with the smallest number on top. The sheets of paper should then be tied together at the top left-hand corner with the string provided.
- 28. Students are not allowed to remove any examination material and stationery without permission. These can include answer booklet, writing paper, storage devices and other used or unused examination stationery from the examination venue.
- 29. Students caught with incriminating evidence will be presumed to have cheated or to have attempted to cheat. Students caught cheating or helping others to cheat will receive zero mark for the paper. They may also be barred from sitting for the rest of the examination papers.

Student Absence

- 30. A student may be excused from sitting for a paper only if he is hospitalized or has a medical certificate. The medical certificate is to be submitted to the form teacher on the day of return to school. A letter of excuse from parents/guardians will not be accepted. *Do note that this does not apply to the national exams. Even with an MC, provisions can be made for students to take the papers.
- 31. Students who are absent from any subject/paper without a medical certificate (MC) from a certified general medical practitioner will be given zero mark for that paper. MC from Traditional Chinese Medicine (TCM) practitioner will not be accepted.
- 32. If a student is unable to sit for a school-based assessment, which includes Weighted Assessments (WA), Prelim Exam and End-of-Year Exam, the student is required to submit his/her medical certification (MC) or provide a letter from parent/guardian with valid reason (VR) stated. Pro-ration or projection of marks may be applied ONLY in exceptional cases.

- · Develop good study habits
 - · Payattention during lessons.
 - · Submit your homework on time.
 - · Revise your work daily.
 - Consult your teacher/friend on topics that you don't understand.

- · Know the exam format.
- · Prepare a study time-table, and follow it.
- · Make time for rest and play in between studies.
